

The past six months have been very exciting for the Great Northern Union. From a National Anthem performance for a Minnesota Vikings vs. New York Giants NFL crowd of 63,761 to the "On to Fame 2009!" show on June 14, the positive momentum has been building. The chorus is now prepped and poised for their competition performance at the Barbershop Harmony Society's International Convention in Anaheim on July 3. The GNU is slated to perform 15<sup>th</sup>, smack dab in the middle of the qualifying groups from around the globe. Director Peter Benson says, "We are ramping up..." (see page two) In the quartet competition, which begins July 1, 52 foursomes have qualified. X-Factor is listed 23<sup>rd</sup> in the order of appearance and Vocality will be the 31<sup>st</sup> to perform. The GNU will also be cheering the efforts of Expedition in the Collegiate Quartet Contest on July 4.

### Director's Corner by Peter Benson

How would the International Champion Chorus do it? That's the question you need to ask yourself every day. Do you suppose that a champion chorus would have two rehearsals a week, bring in the best coaching, rehearse in at least seven different venues, video themselves, go on a retreat, have plenty of sectionals and choreography rehearsals, practice at home, and post an amazing qualifying score at District contest? Wait a minute, THAT'S US! What more could we possibly ask for?

I am so proud of everything we have been doing as a chorus and I am thrilled with the way we are ramping up to contest in Anaheim. Our "On To Fame" performance was fabulous, and perhaps our best shot so far. I am no longer worried about technique, or pitch, or choreography, or nerves on stage, or whether or not you'll deliver, or whether a voice will stick out, or even whether you want it bad enough. There is only one thing that I am still worried about. I am worried that you don't believe we can win! I will admit that it is hard for me to wrap my brain around the idea of beating 150-man choruses, but I remind myself that they are men just like us, average singers with lots of determination. Yes, they both have gold medals, but at one time they each had to earn their FIRST one. When we hit the stage, our mindset cannot be hoping to just win a medal or hoping that we don't mess anything up. "*The greatest barrier to success is the fear of failure.*" - Sven Goran Eriksson (continued on page 3)

## Chapter Update

What a great start to our 2009 concert season! As we reflect on the development and implementation of our strategic plan as the "new" GNU, I'm reminded of our five M's; Music, Marketing, Money, Membership and Mystique. We should be proud of our progress!

**Music:** This is a great strength of our director as he provides us with a wonderful mix of music and music styles.

- Collaborations with St John's, Wissota Voices, The Commodores and The Singers. (three ensembles are new for our concert series)
- New music like Blame It On My Youth, Go The Distance, I'm Gonna Sing 'til the Spirit and Words.

**Marketing:** Great things continue to happen and improve our visibility within our own community.

- 3<sup>rd</sup> annual and most successful and aggressive concert tour in the history of the GNU.
- New performance halls like Ted Mann and great attendance at our shows, even with tough economic times.

- Another CD is being prepared to be released in November.

**Money:** Continued growth in the GNU's budget...it takes money to grow and improve an arts organization.

- Currently have a 10% fund balance; amazing achievement by the board given our economic times.
- Budget has grown from \$75K in 2005 to \$109K in 2009...a 45% increase!

**Membership:** Great growth! We are achieving rehearsal attendance numbers above the 90% levels over the past two months with 75-80 guys attending rehearsals. Keep it UP!

- 75 guys on tour is an increase of 15% from 2007's tour.
- 85 guys on the risers in Anaheim is a 29% increase from Indianapolis.
- New leadership has been added to help broaden our chorus support system.

**Mystique:** This is where the GNU secret sauce is...

- I would argue that the GNU is probably the most talked about (male) chorus right now in the Society and in our own backyard...why?
  - Twin Cities Community – 5<sup>th</sup> successful Concert Season and continued ticket sales growth.
  - Twin Cities Community – Area Guest Artists series are inquiring more than ever about the GNU singing on their programs.
  - Society Community - Posted highest District scores in the history of LOL.
  - Society Community - Two-year layoff from International (without winning International)...the article in the Harmonizer says it all...let's not let them down.

*Are you mentally confident and ready to take charge...GNU style?*

Guys, we have a great thing going on as a chorus. After Anaheim, we have awesome concerts ahead at Como, Grace, Twins, The Singers, District and Finale. Let's keep the momentum going as we strive to become the greatest male chorus in the United States...it will happen if YOU want it to. The journey has only begun!!



The Wissota Voices ([www.wissotavoices.com](http://www.wissotavoices.com)) placed 4th at the Barbershop Harmony Society Youth Chorus Competition in Pasadena, California on January 31, 2009. A total of 12 choruses and over 300 singers were part of the competition which is in it's 2nd year. The Wissota Voices, in their first trip to the competition, earned a score of 68.4 and traveled to Pasadena with 19 singers.

The Wissota Voices is a non-auditioned men's barbershop chorus that originated on the campus of the University of Wisconsin, – River Falls. Scott Perau, who serves as the director, formed the chorus in 2007. Members of the ensemble are not only from UW-River Falls, but also hail from the Twin Cities area, including Great Northern Union Chorus members. The goal of the chorus is to educate young men in the original American art form of barbershop harmony through chorus singing, outreach concerts, school tours, and volunteer performances.



The Great Northern Union Chorus (GNU) will present On To Fame 2009!, a concert featuring 5 Twin Cities singing ensembles that will represent the region in the Barbershop Harmony Society International Chorus and Quartet Contest in Anaheim, CA in July.

The concert will feature award winning ensembles including the Great Northern Union Chorus, Minneapolis Commodores Chorus, Expedition Quartet, Vocality Quartet, and X-Factor Quartet.

The concert event is set for Sunday, June 14, 2009, at 3:00pm at Ted Mann Concert Hall on the campus of the University of Minnesota (2128 Fourth Street South, Minneapolis, MN 55455). Tickets are \$22 and available online at [ticketnetworks.com](http://ticketnetworks.com), phone at 651-209-6689, or email [tickets@gnunion.com](mailto:tickets@gnunion.com). Senior, student, and group discounts are available.

All five ensembles have competed in the Barbershop Harmony Society (BHS) Land of Lakes District over the last year earning their way to be invited to the 2009 BHS International Competition to be held at the Honda Center in Anaheim, California July 2-5. Only the top 20 choruses and top 40 quartets worldwide are invited to the International Contest each year billing the event as the 'Superbowl' of barbershop competitions. This is the first time in history that two Twin Cities Choruses have qualified to compete at the same International Contest.

The Minneapolis Commodores have represented the Twin Cities a cappella choral community at the highest levels for decades, having earned top five (medalist) ratings at several Barbershop Harmony Society International Competitions, while regularly placing in the top 20 of the world's best four part harmony choruses. The Commodores number 100 members strong.

The 85 member Great Northern Union Chorus has earned the right to be considered as one of North America's elite men's a cappella choruses. Since their inception on the mid-1980's, the Great Northern Union's emphasis on excellence in performance has resulted in numerous medalist performances while competing against the "Best of the Best" that the Barbershop Harmony Society has to offer, while consistently earning Top Ten in the World placements over the years.

Currently the Great Northern Union chorus is seeded highest at #3 out of hundreds of competing ensembles world wide.

Joining the concert will be three award winning quartets that will represent the Land of Lakes District in the International Quartet Competition. The Quartets include Collegiate Quartet Expedition,

2007 LOL Quartet Champion Vocality, and 2008 Quartet LOL Champion X-Factor.

If you love great barbershop singing this is the concert you won't want to miss!


